Has participated in at least 2 either national conference or state chapters of IAPSM. A resident of selected zone of Rajasthan State or working in that selected zone**.

*For IAPSM membership upto 15.07.25 will be considered for all the groups including eligible voters

** For resident proof-either of Adhar card/ Electricity Bill/ Certificate from employer will be considered

*Posts are for two years i.e. 2025-27,

** MD(PSM)/ MPH + Given in column as per posts.

IAPSM ELECTION – CODE OF CONDUCT

Code of conduct will be operational with immediate effect with notification of election & will be in force till the results are declared.

Following are the components of the code of conduct:

A. Electioneering:

- a. The following actions are **Not Allowed** by contestants as well as supporters and well-wishers: -
 - i. Advertisements in lay **press**, any kind of press release and **interviews** about the election.
 - ii. Hosting of tea/ lunch/ dinner/ cocktail parties for eligible voters.
 - iii. Eligible voter will be
 1. Member of IAPSM (Permanent) before the date of starting Nomination (i.e. Before 16.07.25)
 2. A resident of Rajasthan State (selected zone in case of Executive member) or working in Rajasthan (selected zone in case of Executive member).
 - iv. **Negative propaganda** about fellow contestants.
 - v. Use of **pressure, inducement or coercion** to get votes from eligible voters
 - vi. **Impersonation** of an eligible voter.
 - vii. Use of any **caste/ religion/ region** or any other methods to influence voter for voting which is against the principle of democracy.
- b. Appeals are allowed in the form of emails / print / electronic media like election letters / brochures/ SMS/ Telephone/ social media.
- c. Posters, distribution of Pamphlets etc. of contestants are strictly prohibited.
- d. Candidate should not be involved in hosting dinners or any other social programs

B. Breach of Code of Conduct:

if: -

- a. A written/ email complaint is received about the conduct of a contestant from a member of IAPSM and confirmed by the EC after investigation. (The complainant has to declare his/her name, IAPSM number & all relevant details needed to identify him/her as a legitimate member of IAPSM.)
- b. Breach of code of conduct is observed by any of the members of Election panel.
- c. The breach is proved with 'documentary' proof (audio/ visual/ print/ electronic).
- d. A documented breach of code of conduct by a contestant may be punishable by disqualification of his / her candidature by Election panel.
- e. Any impersonation or other fraud will be reported to the Police/ President & General Secretary of Marudhara Chapter of IAPSM Society/ IAPSM/ National Medical Commission of India /other appropriate authority within the Jurisdiction of the suspected fraud.
- f. The decision of the Election panel will be final & binding.

C. All contestants will have to give in writing their acceptance to abide by the code of conduct along with application for nomination.
